Key Messages:

- Throughout October, COVID-19 vaccines targeting the latest Omicron XBB subvariants are being prioritized to high-risk groups.
- A new Peel Health Professionals Portal for primary care providers interested in administering COVID-19 vaccines is now live.
- Health care providers can order and provide Rapid Antigen Tests (RATs) on a voluntary basis to their patients.
- Patients must have COVID-19 symptoms and a positive COVID-19 test to receive antiviral treatment.

NEW: COVID-19 Fall/Winter 2023-2024 Campaign

Ontario's Fall/Winter 2023-2024 Campaign for COVID-19 vaccination has begun. Throughout October, COVID-19 vaccines are being prioritized for:

- Hospitalized individuals and hospital staff;
- Long-Term Care Home and Elder Care Lodge residents, staff, and caregivers;
- Individuals at high risk for COVID-19-related complications.

Vaccines will be distributed, as they become available, to participating retirement homes, other congregate living settings, pharmacies, primary care providers and other providers.

The latest vaccine provides greater protection against the currently circulating Omicron XBB subvariants and both mRNA vaccines are authorized for individuals ≥6 months of age:

- Moderna Spikevax®XBB.1.5 authorized September 12, 2023
- Pfizer-BioNTech Comirnaty® Omicron XBB.1.5 authorized September 28, 2023

The Novavax Nuvaxovid® XBB.1.5 vaccine, which is an adjuvanted recombinant protein vaccine, is currently under review by Health Canada.

The Ministry of Health recommends a dose of the XBB.1.5-containing COVID-19 mRNA vaccine for individuals in the authorized age group (i.e., 6 months and older) who have been previously vaccinated against COVID-19 if it has been 6 months from the last dose or known SARS-CoV-2 infection (whichever is later). To accommodate individual health and personal factors that may put the individual at higher risk, a dose may be administered at a minimum interval of 3 months.

Peel Public Health anticipates it will begin to offer the new vaccine formulation at its clinics to individuals at high risk for COVID-19-related complications in mid to late October (subject to product availability). Appointments are to be booked through the provincial booking system:

NEW: Distribution of rapid antigen tests

To support ongoing access to COVID-19 testing and antiviral treatment through the Fall/Winter 2023-2024 respiratory season, health care providers (HCPs) can order and provide Rapid Antigen Tests (RATs) on a voluntary basis to their patients via the Provincial Antigen Screening Program (PASP): https://covid-19.ontario.ca/get-free-rapid-tests

REMINDER: COVID-19 testing and antiviral treatment

Patients must have COVID-19 symptoms and a positive COVID-19 test to receive antiviral treatment (e.g., paxlovid).

A positive result on any of the following test types are sufficient to confirm COVID-19:

- A RAT administered by either the patient (at home) or a health care provider.
 - Note: a negative RAT is not sufficient to rule out a COVID-19 infection. Patients at high risk with a negative rapid antigen test should be considered for confirmatory PCR test.
- ID NOW or other rapid molecular test.
- A lab-based PCR test.

Patients at high risk of severe outcomes of COVID-19 are eligible for PCR or rapid molecular testing at participating pharmacies, hospitals, assessment centres, and select primary care settings.
